## AN ORDINANCE TO ABATE THE SERIES 2010 BOND FOR THE 2012 REAL ESTATE TAX LEVY

BE IT ORDAINED by the Board of Trustees of the Village of Alsip, Cook County,

Illinois, in the exercise of its home rule powers:

**Section 1:** Pursuant to the provisions of Ordinance No. 2010-8-, authorizing the Series 2010 General Obligation Bonds in an amount not to exceed \$3,550,000.00, the tax levied therein is hereby abated as follows:

**Section 2:** That the Village Clerk is hereby instructed to file a certified copy of this Ordinance with the appropriate county officials to abate said portion of 2012 Real Estate Tax Levy.

**Section 3:** That all ordinances or parts of ordinances in conflict with the provision of this Ordinance are hereby repealed insofar as they conflict herewith.

**Section 4:** That this Ordinance shall be in full force and effect from and after its passage as provided by law.
