**ORDINANCE 2012- 12- 4**

**AN ORDINANCE TO ABATE THE SERIES 2002 BOND FOR  
THE 2012 REAL ESTATE TAX LEVY**

BE IT ORDAINED by the Board of Trustees of the Village of Alsip, Cook County, Illinois, in the exercise of its home rule powers:

**Section 1:** Pursuant to the provisions of Ordinance No. 2002-9-1, authorizing the Series 2002 General Obligation Bonds in an amount not to exceed \$5,100,000.00, the tax levied therein is hereby abated as follows:

2012	\$178,065.00	\$105,059.00	\$73,006.00


**Section 2:** That the Village Clerk is hereby instructed to file a certified copy of this Ordinance with the appropriate county officials to abate said portion of 2012 Real Estate Tax Levy.

**Section 3:** That all ordinances or parts of ordinances in conflict with the provision of this Ordinance are hereby repealed insofar as they conflict herewith.

**Section 4:** That this Ordinance shall be in full force and effect from and after its passage as provided by law.


