ORDINANCE 2012- 12-6

AN ORDINANCE TO ABATE THE SERIES 2005A BOND FOR THE 2012 REAL ESTATE TAX LEVY

BE IT ORDAINED by the Board of Trustees of the Village of Alsip, Cook County,

Illinois, in the exercise of its home rule powers:

Section 1: Pursuant to the provisions of Ordinance No. 2005-11-6, authorizing the Series 2005A General Obligation Bonds in an amount not to exceed \$3,250,000.00, the tax levied therein is hereby abated as follows:

Section 4: That this Ordinance shall be in full force and effect from and after its passage as provided by law.
