**AN ORDINANCE TO ABATE THE SERIES 2005A BOND FOR
THE 2012 REAL ESTATE TAX LEVY**

BE IT ORDAINED by the Board of Trustees of the Village of Alsip, Cook County, Illinois, in the exercise of its home rule powers:

Section 1: Pursuant to the provisions of Ordinance No. 2005-11-6, authorizing the Series 2005A General Obligation Bonds in an amount not to exceed \$3,250,000.00, the tax levied therein is hereby abated as follows:



Section 3: That all ordinances or parts of ordinances in conflict with the provision of this Ordinance are hereby repealed insofar as they conflict herewith.


Section 4: That this Ordinance shall be in full force and effect from and after its passage as provided by law.
