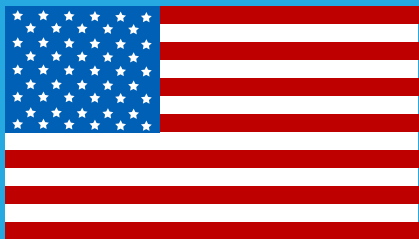

## FROM THE MAYOR'S OFFICE

Hello Village of Alsip Residents & Businesses,

I hope your family is well. One of my primary responsibilities is to keep finding ways to reduce costs, while keeping the Village finances healthy. Please see the following brief examples of what the Village is doing to save money, while never diminishing services. This newsletter doesn't offer enough space to recognize all of our great department heads, but please note these highlights:

**Water Commissioner Dan Tryban** used a Safety Grant, purchased trenching equipment, and trained personnel to repair water main breaks, saving money by reducing sub-contracting.

**Police Chief Jay Miller** and his command staff did an outstanding job of identifying and reducing spending during a pandemic, from \$5.9 million last year to \$5.6 million this year.

**Public Works Supt. Mike Fraider** identified a portable asphalt unit to make smaller street repairs and helped to secure a \$260,000 green infrastructure grant to be used at the Boat Launch.

## FROM THE MAYOR'S OFFICE – *continued from front cover*

**Fire Chief Tom Styczynski** has our eye on possibly purchasing a mini-pumper squad next year that will serve the community well, and reduce the costs of maintenance on the large trucks. Fire reduced spending from \$4.6 million to \$4.3 million.

**Building Commissioner Rodger Early** is assisting me at every meeting to attract and retain business, as we're facilitating millions of dollars of investments which benefit the Village, the Park district, the Schools and the Library and we're blessed to have these job opportunities in the Village of Alsip.

2020 hasn't been a good year for any of us, but please know I'm making many recommendations to offset debt obligations for public safety pensions, where the Trustees agreed to adjust Telecommunication fees to the provider of services (\$240,000) and to adjust gasoline tax (\$650,000), these recommendations won't affect property taxes. I've also recommended a reduction in spending by over \$2.4 million dollars and the Board agreed, as we approved our budget in July but had no idea of what revenues to expect until after property taxes are paid in October, so "We've reduced our spending to live within our means, just as you do when finances are tight"

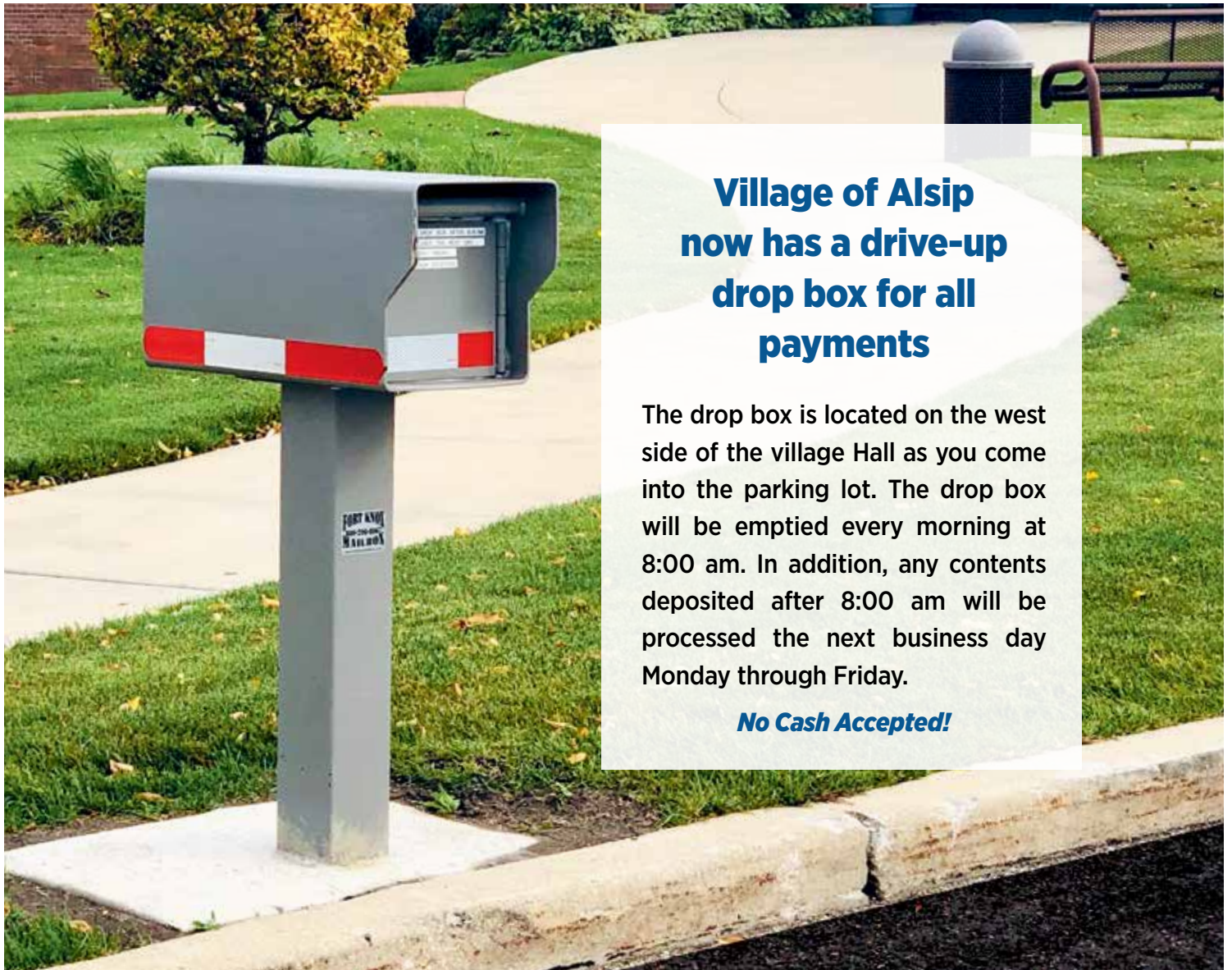
Heading toward the November 3, 2020 Election Day, we wanted the Alsip residents to be made aware that Village Hall will **not** be an early voting location. The Board came to this decision with respect to keeping the residents and Village Hall staff safe by limiting the traffic in the building.

### Officer Receives Lifesaving Award

Officer Delaney received a Lifesaving Award from Chief Miller for the action he took to help a family during his overnight patrol June 30. At about 3:30 a.m., Officer Delaney heard someone shouting in the 11800 block of Springfield Ave. He drove toward the area and discovered a

frantic man outside yelling that his baby was not breathing. Officer Delaney notified dispatch of his location and entered the man's home to render aid.

The mother handed Officer Delaney her limp 4-month-old child. He recognized the baby was in respiratory distress with a faint pulse and immediately administered several back blows to free up any possible airway obstruction. The infant then vomited, cried, and coughed, continuing to show signs of improvement. Officer Delaney stayed with the family until the Garden Homes Fire Protection District arrived to take over care.

## US Postal Service – Issues With Mail Delivery

The Village phones are lit-up daily, with furious complaints about the lack of mail being delivered. Mayor Ryan's office is taking calls from residents whose medicine wasn't delivered, or bills that weren't processed on-time, leaving the recipient with late fees, etc.

Mayor Ryan issued a letter to Congressman Bobby Rush's office, to offer criticism and formally request a resolve, where his office advocates on behalf of everyone affected by an overwhelmed USPS system, to either establish a satellite post office within the Village of Alsip, or re-assign the duties of delivery to another local branch office, as the existing conditions are unacceptable and constituents are demanding action now.

This is a Federal Government issue and unfortunately the Mayor can't intervene, however, we are supportive of the residents who wish to submit letters to our federal representative as well and voice your complaints, as Congressman Rush is aware of the problem, but "WE" need a solution!

# Update from the Fire Department

As you are reading this we are still dealing and battling with Covid-19 that began last winter. This virus has had a definite impact on every aspect of our lives and will continue to do so for a while. We have had to make some significant changes at the fire department over the past few months to protect our firefighters, their families

and the people we serve. For any of you that have used our ambulance service, you have seen that firsthand. Our paramedics take extra precautions and add different types of protective equipment measures depending on the nature of the call. Unfortunately, we have had to stop allowing family members to ride with to the hospital and all of our patients are required to wear face masks while in the ambulance.

In the late spring we had 2 firefighters retire as reported in the spring edition of the newsletter. Since then we have had two new additions to the Alsip Fire Department's family, Firefighter/ Paramedic Patrick Fitzgibbons and Tom Touhy. At the time of this writing, we are also processing another person to fill a vacancy.

We are anticipating him beginning on days October 19th for 2 ½ weeks of training before he is placed on shift. Kyle Galvan and Laura Memmesheimer also completed their probation in May. We congratulate both of them

The Alsip Fire Department also placed a new piece of equipment in service for cardiac arrest patients. It is called an Auto-pulse. It is a machine that provided CPR replacing manual CPR by a human. This allows constant CPR even while moving a patient to the ambulance and

it very effective. It provides a better chance of survival to the patient and also frees up one of our medics to perform other duties needed. As of date, the Alsip Fire Department has had 3 saves since they were put in service. Early CPR is still the best chance of survival, and we encourage all residents and businesses to take advantage of our CPR classes.

The Fire Department's Fire Prevention Bureau did return to its annual inspection program around June 1st. The program provides annual life safety inspections to all businesses (approximately 850) and most apartment buildings (depending on the number of units)(450 buildings).

Our biggest challenge is public education programs. We did return to some classes such as CPR and fire extinguisher training, but on a limited basis. As the time of printing we will have moved away from our traditional open house for 2020 to a reverse drive-by to distribute our fire prevention and public education materials. We felt this is the safest way to get our word out. We also produced several videos on fire safety including our annual side by side demonstration with some added information. The department is still working on a program for home inspections. Covid has slowed this down, but the program is still being developed.

Even though Covid had changed our dynamics of our world and has limited us our firefighters are still hard at training to provide the best service possible. We have been very fortunate to use the former EDCA and Ed's Lawnmower buildings for training. These buildings provide invaluable opportunities for training. Additional training included our acting officer training program which is a 40 hour course for any firefighter who acts up as a company officer while on shift.

The Alsip Fire Department will continue to strive to provide the best possible EMS, Fire and Rescue services to all of our residents and businesses. Our Firefighter/ Paramedics are highly trained, dedicated and committed folks.

## Autumn Leaves

Please do not rake your leaves into street, this can block up storm sewers and lead to flooding in streets and parkways. Please place leaves in a brown paper yard-waste bag or place them in a trash can marked as yard waste. These items will be picked-up on garbage collection day.

## Winter Snow Plow Parking Restrictions

Residents are asked to promptly remove vehicles from village streets at the start of a snow fall. Vehicles are subject to ticketing and towing after a 1" accumulation on marked primary routes and 3" on secondary routes (secondary routes are not marked).

Also, please do not push snow back onto the street as it is unlawful to do so after the street has been plowed. Some snow will overflow onto driveways and sidewalks as part of the plowing process; your understanding of this matter is appreciated.

## Snow Removal Suggestions

An unavoidable result of plowing roadways is that some snow will spill off from the plow blade into driveways. The Alsip Public Works understands how frustrating this can be, especially when residents have already cleared the ends of their drives. The department suggests waiting until the plow trucks have made their final pass along the curb line before shoveling. Information pertaining to the plow driver's status in your area can be obtained by contacting the Alsip Public Works at 708-385-6902 x364 during normal business hours (8am - 4:30pm).

If you cannot wait for the plow truck to make its final pass, the following suggestions are offered as a way to reduce the amount of snow overflowing onto the end of your drive:

- Shovel snow at the end of your driveway onto the parkway to the right (when facing the street). This will help to reduce the amount of snow deposited as the plow truck passes by.
- Clear a portion of the roadway directly to the left of your drive (when facing the street). This will also help to reduce the amount of snow deposited as the plow truck passes by.
- Not depositing snow from your driveway into the roadway will also help to reduce the amount of snow that could be plowed onto your drive.



## Asphalt Trailer

Alsip Public Works recently took delivery of a new trailer mounted Pre-mix Heater Asphalt Hot Box. This equipment will assist Public Works crews to repair potholes more effectively and efficiently. The heated asphalt material comes out hot, making it easier for staff to work with and bonds to street for a more permanent repair.

We are heartbroken and truly disappointed; we look forward to 2021 when we all can celebrate these great events again.

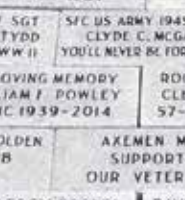

## Frequently Asked Snow Questions

As an ongoing effort to provide the best possible snow removal service to its residents, the Alsip Public Works offers answers to these most commonly asked questions.

### Q: Why does it take so long to remove snow from our streets?

**A:** We are proud that the response time to clear Village streets on an average snowfall of four to six inches only takes about 12 hours. Heavy wet snows, harsh plowing winds, sub-zero temperatures and vehicle traffic may complicate snow removal efforts and cause delay. We utilize all of the equipment and manpower available but must also maintain the many other Village services we provide.

### Q: Why do I always see snow plows on other streets before mine is done?

**A:** Arterial and collector streets in the Village carry higher volumes of traffic. The chances of accidents are greater and these streets demand our first attention. Also, it is important for us to maintain a consistent pattern as our manpower and equipment resources dictate following a specific plan. In order to cover all areas of the Village as efficiently as possible, this consistency is necessary to evaluate and update our snow program for future storms.

### Q: Why is there a difference in the snow removal efforts on certain streets?

**A:** Some streets, such as 127th Street and Cicero Avenue, are maintained by the State of Illinois. Other streets may be maintained by the Cook County Highway Department, Worth Township or the management company of your private drive. Any questions pertaining to road jurisdiction should be directed to the Public Works Department.

### Q: Why does it seem that the snow plows arrive just after I finish shoveling my driveway?

**A:** This question is probably one of the most commonly asked questions by our residents. Unfortunately there is no easy answer to resolves this situation unless the

homeowner waits until snow plows have made their final passes along the curb line- usually their forth pass down a street. Standard operating procedure requires the snow plow route driver to open the center of the road first. If you can not wait until the driver returns for the curb line, you may have to remove some snow from the end of the driveway. On average, it takes about five hours before a driver can return to do the curb line.

### Q: Why was my car plowed in?

**A:** Village ordinance prohibits parking on Village streets during snow cleanup operations. Our drivers will not avoid plowing streets with illegally parked vehicles. These vehicles risk not only being ticketed and towed, but also being plowed in. Illegally parked vehicles are the number one handicap cited by our snow plow drivers. They create a hazard and reduce the effectiveness of our program.

### Q: How can I help and what are my responsibilities as an Alsip homeowner?

**A:** Your patience and cooperation are the most important factors in helping us do our job of snow removal for you. Please do not push snow from driveways and sidewalks back into the street as it is illegal to place any substance- such as snow, ice or dirt- upon the public way or public right-a-way. Please promptly remove vehicles from Village streets at the start of a snow fall. Illegally parked vehicles delay snow removal operations and are subject to ticketing and towing. Keep the area leading to your mailbox clear of snow and place garbage cans behind the curb on garbage collection day. If you have a fire hydrant in front of your home, please help to keep it visible. Report hydrants hidden by snow. Your cooperation with these requests will greatly reduce complications and is appreciated.



The Beautification Committee is asking residents to help pick up garbage while out walking. If residents could pitch in and we work together during this time, we can still ***Keep Alsip Beautiful!***

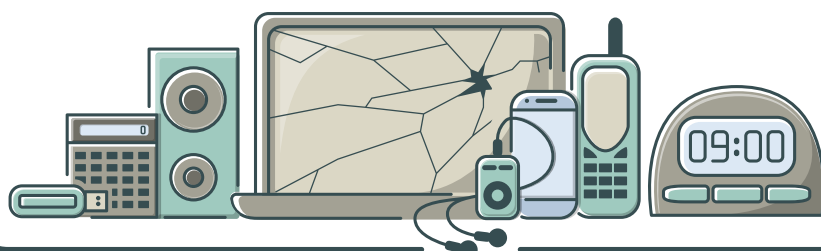
